

Hands-On Injectables Training

Two-Day Practical Schedule

Important clarification

This hands-on training focuses on **one specific injectable category per two-day training**. Participants do **not** learn all injectable treatments simultaneously during a single course. Each training is dedicated exclusively to the selected treatment type, such as *Botulinum Toxin*, *Hyaluronic Acid Fillers*, *Radiesse*, *Sculptra*, or *PDRN*.

Combination training across multiple injectable categories is possible only by enrolling in separate two-day hands-on programs, each preceded by completion of the corresponding online theoretical course. For consecutive or combined training days, participants must contact the training provider in advance to discuss eligibility, scheduling, and prerequisites.

Applicable to one selected injectable per course:

- Botulinum Toxin
- Hyaluronic Acid Fillers
- Radiesse
- Sculptra
- PDRN

This hands-on program is part of a structured training pathway. Successful completion of the designated online theoretical course and final assessment is mandatory prior to participation in the practical training days.
